NOTICE OF PROVISIONAL BYLAW AND NOTICE OF COURT OF REVISION

YOU ARE HEREBY NOTIFIED that the Council of The Corporation of the Town of Bradford West Gwillimbury gave first and second reading to By-law 2020-101 on the 3rd day of November, 2020 under Section 46 of the *Drainage Act*, Revised Statutes of Ontario 1990, Chapter D.17 in respect of approval of the Final Engineer's Report dated September 18, 2020 for the **River Road Drain**. to consider appeals of assessment that have been estimated in the Engineering Report, dated **September 18, 2020**, prepared by K. Smart Associates Limited for the **River Road Drain**.

Pursuant to Section 52(1) of the *Drainage Act*, an owner of land assessed for the drainage works may appeal to the Court of Revision on any of the following grounds:

- Any land or road has been assessed an amount that is too high or too low;
- Any land or road that should have been assessed has not been assessed; and/or
- Due consideration has not been given to the use being made of the land.

Pursuant to Section 52(2) of the *Drainage Act*, objections or appeals to the assessment <u>must</u> be forwarded in writing, to the attention of the undersigned, <u>rwestlake@townofbwg.com</u>, at least ten (10) days prior to the above noted Court of Revision date. Therefore, written appeals <u>must</u> be filed with Ruth Westlake, Holland Marsh Drainage System Joint Municipal Service Board Coordinator on or before **Friday**, **November 20, 2020 at 4:30 p.m.**
